BOARD MEETING MINUTES

February 20, 2018 – 3:00 PM Regular Meeting

The Rockingham County Board of Elections met Tuesday, February 20, 2018, at 3:00 pm in the Board of Elections One Stop Room.

ITEM #1 - MEETING CALLED TO ORDER

The Board meeting was called to order at 3:00 pm by Chair Reece who also welcomed those in attendance.

ITEM #2 - APPROVAL OF AGENDA

Secretary Loy made the motion, seconded by Member Richardson, and the vote was unanimous to approve the Agenda for this meeting.

ITEM #3 – APPROVAL OF MINUTES

Member Richardson made the motion, seconded by Secretary Loy, and the vote was unanimous to approve the minutes of the January 16th Regular Meeting as amended.

ITEM #4 - PUBLIC COMMENTS

Ronald Price, Rockingham Republican Party, Reidsville NC

There are two issues regarding early voting. The question about Sunday voting, I do not believe we should have Sunday voting. We have an extended period of time for voting and the voting day. I remember when voting was one day. We have extended the voting time to a considerable amount of time for people. It's an extreme cost for the taxpayer and that's one of them to save on expenditures is to not have Sunday voting. That's the Lord 's Day and we should not be using it for public activities. The other is early voting and how much time we really need for early voting. When I was young, people voted on one day. Additional time is good, but the amount of time we have for early voting is a problem. I would like to see that number reduced and make it public because it is an expense and loads down the staff. I am against Sunday voting. Our Lord and Savior Jesus Christ got mad about people making the wrong use of His house. Sunday should be about the Lord. ITEM #5 - 2018 PRIMARY ELECTION ONE STOP PLAN

Director Cardwell presented to the Board a packet including the following: Memo from Kim Strach directing that One Stop Hours Matching has ceased, Emails from Josh Lawson regarding non-unanimous One Stop Plans, One Stop Officials Pay Chart, 2018 One Stop Schedule Templates, One Stop Schedules for previous Primary elections, and One Stop Daily Totals for previous Primary elections.

Chair Reece discussed the cost of One Stop Voting vs. voter turnout for Primary elections. The Board discussed the number of days remote One Stop Locations could be open and reviewed Option #1. Member Richardson suggested opening remote One Stop Locations for five (5) days. Chair Reece suggested opening remote One Stop Locations for three (3) days. Chair Reece and Secretary Loy stated they are opposed to Sunday voting.
