The Board began to review and open the 31 absentee ballots with photo ID exception forms that had been received into the office, date stamped when received, and the ballot envelope reviewed by staff to make sure the requirements were met for eligibility.

8 of the absentee ballots with the photo ID exception forms were not filled out correctly and needed to be cured.

Member Cole moved, seconded by Secretary Totten to approve the 23 absentee ballots with the photo ID exception forms that were received. The motion carried unanimously.

Member Hampton moved, seconded by Secretary Totten to have 8 absentee ballots with the photo ID exception forms put through the cure process with the MAT Team. The motion carried unanimously.
