ITEM #1 – MEETING CALLED TO ORDER

ITEM #4 – APPROVAL OF THE AGENDA

ITEM #5 – APPROVAL OF MINUTES

The Director stated that an email was sent to the three political parties in Rockingham County on Thursday, September 26th and attached to that email was pictures of the precinct sites showing the buffer zones and electioneering areas. She stated that she had asked the political parties to respond back to her no later than Friday, October 11th and she did not receive any responses back from the political parties.

The Director informed the Board that Chairman Charlie Hall of the Rockingham County Board of Commissioners mailed a letter to the NC State Board of Elections to ask for reimbursement of the

She added that 1679 Absentee by Mail ballots were mailed out today, October 15, 2024. The Director stated that the Logic and Accuracy Testing took place on Tuesday, October 1st and the Mock Election took place on Thursday, October 3rd.
